ADVOCACY: AN IMPORTANT NEED FOR DOCTORS: A MESSAGE FROM THE PRESIDENT OF HCMS.

We had the pleasure of having Dr. Robert Jackson speak at our annual CME event where he stressed the importance of why we as doctors need to do more advocating for ourselves and our lives. He highlighted the large gap in what the reality of our worlds are and what the legislative vision of our world is. I invited Dr. Jackson to address this with a write-up so all our members can gain from his wealth of knowledge and leadership. As the largest county medical society in the nation with more than 13,000 members, the Harris County Medical Society (HCMS) supports physicians across diverse specialties, practice settings, and career stages. Along with the Texas Medical Association (TMA), HCMS offers many benefits aimed at assisting our members and protecting the House of Medicine.

Advocacy

At the heart of HCMS's mission lies a steadfast commitment to advocating for physicians' legislative and regulatory interests. During each legislative session, the TMA and HCMS track and guide state legislators on healthcare-related bills. Additionally, the TMA and HCMS sponsor First Tuesdays at the Capitol so our members can provide a first-hand account of how regulations and laws impact physicians, their patients, and their practices.

In recent legislative sessions, HCMS played a pivotal role in advancing key priorities such as safeguarding physicians' scope of practice, preserving standards of care, and addressing public health challenges. In 2023, HCMS and TMA were successful in getting the Texas State Legislature to extend postpartum Medicaid coverage to a full year.

Additionally, we successfully defended tort reform and did not allow liability caps to increase. Finally, TMA and HCMS followed up on the 2021 gold card success with a new prior authorization reform for vulnerable patients and other insurance-related policy wins.

These efforts underscore HCMS's dedication to ensuring a favorable environment for physicians to deliver high-quality care to their patients.

We also advocate for physicians with insurance companies to address burdensome policies that impact physicians, reimbursement, and patient care. For example, Cigna's proposed modifier 25 policy in 2023 would have increased administrative burdens for physicians, discouraging modifier 25's use and reducing payments. Through HCMS and TMA advocacy, this policy change was successfully blocked.

Also, for Texas county medical societies, HCMS led in offering its members crucial guidance on navigating the repercussions of the recent cyberattack on Change Healthcare. This attack led to the shutdown of Change Healthcare's systems and some of its key partners being disconnected. This incident had

national consequences, affecting physicians and patients alike, with disruptions in claims submissions, payments, prescriptions, and various other services.

Membership Benefits

HCMS membership opens doors to many benefits designed to meet the evolving needs of physicians and their practices. With more than 100 member benefits ranging from practice management resources to wellness programs, HCMS strives to provide unparalleled value to its members all for the minimal cost of HCMS's yearly membership.

One example is our Payment & Practice Help Program, which assists in resolving payer-related issues and practice management concerns and has helped physicians reclaim over \$30 million in improperly paid claims since its inception, all free of charge for HCMS members.

Additionally, HCMS offers educational opportunities, networking and social events, resources to grow patient referrals, and access to professional development resources to support physicians in navigating the complexities of modern healthcare.

Whether you are a seasoned practitioner or a young physician navigating the early stages of your career, HCMS offers opportunities to expand your network and get valuable continuing medical education through our seven geographical branch meetings. HCMS holds multiple

social events throughout the year. In 2023, we held two social events for members and their families. Both events had over 100 participants and provided our members with the opportunity to build relationships with other physicians from all practice settings and specialties. Our next member social event, Porsche and Prosecco, will be held April 18 at the Porsche West Houston dealership from 7 to 10 p.m. All HCMS members are invited to join me, so please RSVP.
